Lucas Wilson

This past year, Lucas had some of his academic and public-facing work published. His book chapter, titled "Dismantling Christian Readings of Jewish American Literature in the Christian College: A. M. Klein's The Second Scroll," was included in Teaching Jewish American Literature, published by The MLA. He also has forthcoming articles being published in The Journal of Jewish Identities and Canadian Jewish Studies, along with book chapters slated for publication by The University of Alabama Press and DIO Press. His public-facing work has appeared in LGBTQ Nation, Religion Dispatches, Queerty, and RVA Magazine. He has also been interviewed by several media outlets—like Rolling Stone, Straight White American Jesus Podcast, A Tiny Revolution, etc.—about his work on gay conversion therapy.

Lucas furthermore presented his work at several conferences, including the Association for Jewish Studies Annual Conference; the Western Jewish Studies Association Conference; and the University of California—Riverside Conference on Queer and Transgender Studies in Religion; and he also chaired at panel at the Northeast MLA. Additionally, Lucas has been invited to participate in several working groups, workshops, and institutes; he has been invited to be part of the Holocaust Educational Foundation's Regional Institute on the Holocaust and Jewish Civilization; the American Academy for Jewish Research's Workshop for Graduate Students; and University of Sussex's Max and Hilde Kochmann Summer School; and he is currently part of The University of Alabama's American Examples Program.

Lucas has also received several awards and fellowships over the past year, including The Honor Society of Phi Kappa Phi's Dissertation Fellowship; Sigma Tau Delta International English Honor Society's Edwin L. Stockton Jr. Graduate Scholarship; the Northeast MLA's Graduate Student Caucus Essay Award; Oral History in the Mid-Atlantic Region's Martha Ross Memorial Prize; Michigan State University's Libraries Travel Grant; University of Minnesota's Elmer L. Andersen Research Scholarship; the American Academy for Jewish Research's Graduate Student Summer Funding; and the Association for Jewish Studies' Charles Knapp Family Foundation Conference Subvention Grant. From FAU, Lucas received the Summer Dissertation Fellowship. Lucas is currently teaching at University of Toronto while finishing his dissertation.

Dr. Dyanne K. Martin

"Of Race and Resistance: Inside and Out of Ethnic Lives in Modern Literature of the Americas"

Dyanne Martin is a native of Jamaica, a country whose national motto is "Out of many, one people." Her multicultural background fosters her deep interest in diasporic literatures across the Americas, with an emphasis on Caribbean literature. Her areas of scholarship also include classical rhetoric, semiotics, and Holocaust studies. Her research in the expanse of ethnic literatures examines identity formation, as well as overlooked spaces of healing and reconciliation.

Dr. Martin's dissertation, "Of Race and Resistance: Inside and Out of Ethnic lives in Modern Literature of the Americas," explores—through the genres of slave narrative, fiction, and memoir—the ways in which people understand and perform race. She examines the process of socio-semiogenesis in which customs allow people not only to form themselves in groups but also to disrupt, remediate, and invert the implicit racial codes that govern human interaction within and among such groups. Her study offers a Peircean, triadic approach to the dialectics of race—an approach that seeks to find a space in which dialogue and healing might occur even as it sheds light on those shades of biology and culture that both form and divide ethnic groups. Her peer-reviewed publications have appeared in the ALAN Review, Ideas Plus, the Philip Roth Journal, and the CEA Critic.

Dr. Martin has been teaching for twenty-two years, twelve of which were spent in secondary education—an invaluable experience she would not trade. After obtaining a tenured position at Broward College, she was blessed and humbled to be awarded both Professor of the Year and John S. and James L. Knight Endowed Teaching Chair. She will always be grateful for the colleagues and students she was privileged to know at Broward College. Dr. Martin now teaches Caribbean Literature, African American Literature, Holocaust Literature, Advanced Rhetoric, Visual Rhetoric, and Core Studies at Wheaton College in Wheaton, Illinois, where she has been awarded an Aldeen Grant and a Global Program Studies Curriculum Grant.

Her dissertation committee, chaired by Dr. Mary Ann Gosser Esquilín, included Dr. Sika Dagbovie-Mullins, Dr. Richard Shusterman, and Dr. Steven Blakemore. She is forever indebted to her stellar committee for their incomparable expertise and encouragement. She is also grateful for the instruction and guidance received over the years from Dr. Alan Berger and Professor Ayse Papatya Bucak, as well as for the knowledge she gained at Cornell's School of Criticism and Theory. In addition, Dr. Martin is thankful for the support of her husband, her family, and the friends in her cohort who became family: Amanda Dutton and Cora Bresciano.

Dr. Lochard Noël

"Du Fantastique Français au Réel Merveilleux Haïtien: L'incontournable va-et-vient Littéraire"

Dr. Lochard Noël was drawn to the Comparative Studies program because the program's interdisciplinary structure would allow him to incorporate the methods, philosophies, and perspectives from several fields of study, namely Literature and cultural Studies, Anthropology, and Post-Colonial studies. He started the program in the fall of 2014 and graduated in the fall of 2020. His research focuses have centered on French Fantastic literature and "Le reel merveilleux haïtien" culture, religion, zombification, and the influences of dictatorial regimes on literary works, fiction and non-fiction. In addition, Dr. Lochard Noël has more than 20 years of teaching experience, which include teaching high school ESOL students from Miami Dade County Public Schools, Union School in Haiti where he taught English, French and Social Studies for three years. Dr. Lochard Noël has published numerous works including novels, poetry, folktales and articles on arts and literary critiques. Dr. Lochard Noel is a member of the cultural group Sosyete Koukouy (Koukouy Society) since 1985. Prior to entering the Comparative Studies Program, Dr. Lochard Noel received his master's degree in French from FAU. His doctoral dissertation was supervised by Dr. Mary Ann Gosser Esquilín, Dr. Marcella Munson and Dr. Romain Rivaux.


Dr. Carmen Duarte

"Cuando las Islas Tienen Alas: Diversidad e Inclusión Étnico-Racial y de Sexualidad en la Dramaturgia Femenina Hispano-Caribeña en los Estados Unidos"

Carmen Duarte's doctoral dissertation, "Cuando las islas tienen alas: Diversidad e inclusión étnico-racial y de sexualidad en la dramaturgia femenina hispano-caribeña en los Estados Unidos" was successfully defended in 2021. It is to be published by Editorial Aduana Vieja later on this year. Duarte, a Cuban playwright who emigrated to the United States in 1993, joined the Comparative Studies program in 2017 with the idea of doing research on Hispanic Caribbean women playwrights in the United States. Dr. Mary Ann Gosser-Esquilín, an expert in Caribbean literature accepted to be the Director from the onset of the project. Later, Dr. Nancy K. Poulson, an expert in Latin American literature and Dr. Carmen Cañete-Quesada, an expert in Dominican literature became the other members of the dissertation committee. The dissertation was completed during the COVID 19 pandemic, when to check out books from a library was a difficult process, and when it was not possible to conduct research in the archives of theatre groups in other states or seek other theatrical works for the project. Thanks to the internet and social media, we talked to specialist, libraries, and collected many plays, biographies, further bibliographic information, and even some theater shows. Despite the difficulties, we brought to fruition this ambitious dissertation, focused on the intersectionalities of ethnic, race, sex and gender identities of Hispanic Caribbean women in the United States though the study of their dramatic productions. Duarte has many other future projects as a playwright, novelist, and also as a researcher. In the immediate future she intends to continue the study of Hispanic Caribbean women playwrights in the diaspora, but not just in the United States, but also in Europe and Latin America.





True glamour is a particularly elusive phenomenon, rare and easy to miss in our social media age. What is it in the collective imagination? A couture Balenciaga dress, a customized Bugatti, or some other accoutrements of the cultural or financial elite? If so, how is it that we also discern it in someone who has no apparent position of power power position of power or wealth? A truly glamorous person is like an original artwork on Walter Benjamin's model, which has an authenticity, a uniqueness—an aura. Thus, the work's aesthetic value is lost in mechanical reproduction. Similarly, Gould analyzes, one cannot copy the glamour of another person, for true glamour emerges from the interior self.

Carol S. Gould, Ph.D., explores why we need a philosophy of glamour and what it can show us about the aesthetics of everyday life and the ontology of personhood as an aesthetic category. She specializes in ancient philosophy, aesthetics, philosophy of literature, and philosophy of psychiatry. Her book titled Aesthetics, Glamour, and Persons is forthcoming with Bloomsbury Academic. The portrait is not the first product of an algorithm that is classified as art. It was preceded by Tresset's art-painting robot and Weinberg's marimba-playing robot improvising jazz, to name a few. This Symposium will examine whether these works can be considered art and explore the role of the human operator.



Yanai Toister, Ph.D., discusses the ideas in his new book which introduces two conceptual models of photography: the Turin Shroud and the universal Turing machine. The Turin Shroud inspires a discussion on photography's frequently acclaimed 'ontological privilege.' This is then contrasted with a discussion on the universal Turing machine.

Yanai Toister is an artist, curator and educator serving as Director of the Unit for History and Philosophy at Shenkar College of Engineering, Design & Art in Israel.
