HSC 5143 Substance Abuse – Research Position Paper Rubric

Research Position Paper: A position paper is a written means of communicating the research and logic process involved in arriving at and establishing a policy, regulation or procedure. The process should employ all the principles and techniques of scholarly investigation. The research involves collecting facts and information to support or disprove the hypothesis. It is always important in research to remain objective and avoid injecting personal bias into the study and its conclusions. For this reason, the process should employ quantifiable factors as much as possible. Only after the facts have been studied should the position statement be established.

Major Divisions of the Paper

Introduction: This should be a brief explanation of the problem and issue that is being proposed, the reason(s) for the need of a policy on the topic, issues impacting the subject, etc.

Methodology: A description of the methods used to establish the position. This could be analytical measurements, survey, literature research with citation of references. Hint: basically you will be summarizing the methods used to collect/analyze data that was used to form the Conclusion in the research article.

Discussion: A presentation of the information, facts, data assembled in the study that support the position statement. Here is where you related the research article findings in such a way that it lends support for your position.

Position Statement: A short, clear statement of the position (example: It is the position of this study that (your position, either support or reject a change in the current legal status of marijuana in the state of Florida) should be considered by the State of Florida. This should be the last sentence in your paper.

Note: You must cite a minimum of 10 peer reviewed journals using APA format.
