THIS GRADUATE CERTIFICATE PROGRAM IS NO LONGER BEING OFFERED. THE PROGRAM WAS INITIALLY ESTABLISHED AS A MEANS FOR RAISING EXTERNAL REVENUE FOR THE SCHOOL, BUT THE REVENUE-SHARING ARRANGEMENT WAS DISCONTINUED BY THE UNIVERSITY. NOW IT NO LONGER MAKES SENSE TO OFFER SO MANY COURSES IN THIS AREA, TAUGHT PRIMARILY BY ADJUNCTS. FACULTY DESIRE TO FOCUS ON THE SCHOOL'S CORE PROGRAMS RATHER THAN DEVOTE RESOURCES TO PROGRAMS THAT ARE TANGENTIAL TO ITS MISSION. ARRANGEMENTS HAVE BEEN MADE WITH STUDENTS CURRENTLY ENROLLED IN THE PROGRAM TO ENABLE THEM TO COMPLETE IT.
