COURSE DESCRIPTION: A choral ensemble performing a wide repertoire of choral literature.

COURSE OBJECTIVES:

- Perform at a high level of performance through the opportunities available in rehearsals, concerts, and all other choral orientated activities.
- Demonstrate musical styles and performance practices in various stylistic periods through rehearsal and performance.
- Improve musical skills through the rehearsal process in musical selections and sight-reading.

OUR CURRICULUM IS DESIGNED TO EXPOSE VOCAL STUDENTS TO THE FULL ARRAY OF VOCAL MUSIC CULTURE. THEREFORE, AS PART OF YOUR EDUCATIONAL EXPERIENCE YOU WILL BE EXPECTED TO SING SECULAR TEXT, SACRED TEXT, PATRIOTIC SONGS, AND HOLIDAY THEMED REPERTOIRE. PLEASE NOTE THAT BY SINGING THIS MUSIC, YOU ARE NOT BEING ASKED TO ESPOUSE ANY RELIGIOUS BELIEFS OR TO ACCEPT AS YOUR OWN ANY IDEOLOGICAL POINT OF VIEW. YOU ARE MERELY BEING REQUIRED TO PARTICIPATE IN CLASSROOM EXERCISES; WHICH ARE ESSENTIAL COMPONENTS OF THE VOCAL CURRICULUM AT FLORIDA ATLANTIC UNIVERSITY. THESE WORKDS ARE PRESENTED AS WORKS OF ART. THEREFORE, YOU WILL BE REQUIRED TO SING ALL SELECTIONS, AND PARTICIPATE AT ALL SCHEDULED REHEARSALS AND PERFORMANCES, WITHOUT REGARD FOR RELIGIOUS OR IDEOLOGICAL BACKGROUND.

- **REQUIRED:** The "Black Folder" is available at the University Bookstore and MUST be purchased for use in class and at concerts. **This is the only acceptable performance folder.** You can purchase at https://www.musicfolder.com/music-folders
- **REQUIRED:** Choral uniform must be purchased through the choral department and paid for in full by the end of the **second** week of classes.
- Each individual will receive assigned music, which belongs to the Choral Studies area at FAU and must be returned in its entirety to the Department without markings (must be erased before submission), on or before the final exam period.
 - o If the physical scores are not returned a hold will be placed in the student's academic records through the Registrar's Office.
 - o If a student looses a score(s) he/she is responsible for the current replacement cost. If the student fails to follow-up with replacement payment a hold will on academic records through the Registrar's Office will follow.
 - The same procedure as above will follow for damaged music.
- Occasionally students will be asked to print public domain scores or manuscripts from Blackboard. Once posted they are the student's responsibility and must be brought to class in hard copy format.
- Each student is required to have A PENCIL at every rehearsal. One (1) point will be deducted for every time a student is identified for not having a pencil during rehearsal.



COURSE REQUIREMENTS:

- 1. This course requires an average of 7 hours per week including rehearsals and practice and/or memorization of music outside of the regularly scheduled rehearsals.
- 2. Students eligible to enroll in this course
 - Music majors who have passed a formal audition and has been approved by the chair of the area of choral and vocal studies
 - Student who are not music majors must audition for the choral faculty and ensemble assignment approved by the chair of the area of choral and vocal studies
- 3. A positive attitude throughout rehearsals and performances is expected.
- 4. The distributed / posted semester schedule is mandatory, including the required recorded submissions per this syllabus.
- 5. Any conflicts with the schedule must be brought to the director's attention during the **FIRST WEEK** of classes.
- 6. Five points will be deducted from the final grade for disruptions to class. This will include, but not be limited to, texting, cell phone rings, and talking.
- 7. ALL DRESS REHEARSALS ARE MANDATORY. ANY STUDENT WHO MISSES A DRESS REHEARSAL WILL NOT BE ALLOWED TO PERFORM IN THE CONCERT RESULTING IN A MISSED PERFORMANCE. OFTEN REHEARSALS AND PERFORMANCES WILL TAKE PLACE ON FRIDAYS, SATURDAYS, AND/OR SUNDAYS. PLEASE BE MINDFUL THAT THERE WILL BE NO EXCUSED ABSENCES FOR THESE EVENTS.
- 8. During the course of the semester other choral activities might be scheduled and thus become mandatory. All extra opportunities will have no less than one-week notice. If a performance/rehearsal opportunity arises with less than one-week notice the group will decide by majority vote if it will become mandatory. However, if an extra rehearsal arises due to lack of progress, such rehearsal becomes mandatory when scheduled by the director. Any significant problems must be brought to the director's attention at the time of the announcement; otherwise it will not be excused.
- 9. Music folder with your assigned music is required at every rehearsal and performance. Students without music and pencil may be dismissed from rehearsal, thus receiving an absence for the day.
- 10. Each student must be prepared to sing alone or in other given formats at every rehearsal. Every student needs to anticipate that he/she may be called upon to sing without prior notice. At certain times pieces will require memorization. All pieces assigned to memory will be given a goal deadline. If a student is called upon to sing any of these pieces in rehearsal he/she must do so by memory.
- 11. Sectionals that are scheduled by the director are mandatory. All others are strongly recommended.
- 12. Relative progress should be evident at EVERY rehearsal. Singing tests (solo or in a small ensemble) will transpire, announced or as a pop quiz format, throughout the course of the semester. Every piece in the repertoire will have a "learned" deadline. Students will submit recorded portions online of given sections in every piece per the class schedule.
- 13. The ensemble's concert attire is mandatory. The uniform should be neatly pressed and well maintained. If a dress is too tight or too short, the student may be asked to acquire one that meets the Ensemble's standards.



- 14. Some piercings may need to be removed for rehearsals or performances. These include tongue, nose, other facial, and ear.
- 15. Music must be turned in at the end of the semester in good condition (no writing or water stains, etc). If it is not acceptable or missing (by assigned number) you will be charged the current replacement cost of each score.
- 16. Hair color that will be a distraction or break the uniformity of the ensemble will need be covered with a wig (i.e, green, purple, series of ... any color that is not the "normal pigmentation")

COURSE COMMUNICATION POLICY:

- Announcements
 - You are responsible for reading all announcements posted by the instructor as well as emails.
 Check the announcements each time you login to be sure you have read all of them since your last login session.
- Email & Message Policy
 - o All electronic communication must originate from a valid FAU email address
 - Except for Saturdays, Sundays, and holidays, instructors will respond to messages generally within 48 hours.
- If this course does not appear in your Canvas list, it is likely that you are not fully registered. If you do not have canvas, you will not receive emails, announcements, or materials for class.

GRADING:

- GRADING BEGINS WITH ATTENDANCE PER THE CHART BELOW
- Every student is responsible to learn EVERY assigned score. Once the score is introduced in rehearsal it is the responsibility of the individual chorister to secure the fundamental knowledge required of every singer. The ensemble rehearsal is NOT defined as scheduled time to spoon-feed the fundamental elements of music. The student is expected to come prepared to every rehearsal. The student is expected to submit recorded singing assignments online to demonstrate knowledge of scores.
 - Definition of being prepared for rehearsal means that the student has taken the responsibility to secure pitches, rhythms, diction, and vocal placement on their own after the score has been introduced at rehearsal.
 - O Definition of rehearsal means that based on the individual chorister's preparation, the conductor will be able to rehearse and unveil the artistic values of every score within any given concert program format with the goal of promoting the art of choral singing. Through the process of rehearsal choristers learn beyond the printed score; interpretation, performance practices, ensemble sound, conducting gestures appropriate to each score, text settings, etc., etc.
- In the event that the ensemble is not presenting the acceptable progress towards successful performances, the conductor will schedule a singing test. The objective of this type of test is to evaluate if the individual student has taken the responsibility to keep up with each assigned score. This means that the student has been attentive during every rehearsal, has marked the score based on the progress of each rehearsal, has taken the responsibility to take any issues to the practice room to make sure that individual progress is maintained, etc. This course does not provide any student the opportunity to select his/her own pacing for score knowledge and progress. It is an ensemble and its



performance will be as strong as its weakest member. This is a valuable lesson to learn for every student aspiring to be a musician in the area of vocal and choral performance.

- Each test will be assessed as High Pass (Will not deduct any points from the final grade),
 Pass (will deduct 5 points from the final grade), and Fail (will deduct 10 points from the final grade).
 - If testing becomes necessary, the test will be given two weeks prior to a scheduled performance.
 - If a student scores a Pass he/she will be given another opportunity a week prior to the scheduled performance. At this point if the student does not score a high pass, he/she will be removed from the performance and 20 points will be deducted from the final grade.
 - If a student fails the first test he/she will NOT be given another opportunity to test and will be removed from the respective performance. At this point the student will not be allowed to participate in the respective performance, thus receiving a failing grade (F) for the semester. The student has the opportunity to raise it to a C- if the test for the second concert is a high pass.
 - These tests will be in an audio recorded corded format and administered by an assigned graduate teaching assistant and submitted to the conductor within 24 hours of administering the test.
- O Basically, a student knows the music or does not know the music, therefore, technically the scoring should be Pass or Fail. However, the main objective is to guide the student through a positive learning experience given the circumstances as well as for the conductor to take into consideration that "nerves" may play a part in the testing process. For this reason, the "Pass" grade has been incorporated.
 - **High Pass** = the student knows the scores at performance level (all pitches and rhythmic notation are accurate; intonation, diction, phrasing, and musical nuances are at performance level).
 - Pass = the student has a good grasp of the score but demonstrates some difficulties that can be corrected upon identification and practice. In this case the student will be retested.
 - Fail = the student DOES NOT know the score and is presenting significant issues with knowledge of notes, rhythmic gestures, and all other identified criteria. Based on the definition of ensemble, it is not fair for this student to be allowed the opportunity to "cram" the music at the last minute prior to a performance.
- Concert Attire is expected to be neat and to follow the detailed guidelines in this syllabus. It is a graded component of this course.

THE STARTING VALUE OF THE GRADE WILL BEGIN WITH ATTENDANCE AS OUTLINED IN THE CHART BELOW. Attendance Grading Criteria

• Note that more than 9 absences (or the correlating number of late arrival to rehearsals or special call times)) will make it impossible to pass this course as required for degree even with documentation. In addition, do not assume that all types of documentation will excuse any absences or late arrivals. It will be up to the discretion of the instructor.

^{**}Five points will be deducted from the final grade for disruptions to class. This will include, but not be limited to, texting, cell phone rings, and talking. **

SOME REHEARSALS AND EVENTS WILL COUNT DOUBLE. THEY INCLUDE:

- All extra rehearsals scheduled with at least one week's notice.
- The mandatory Annual Choral Retreat (the first Saturday of Classes in the Fall semester).
- The LAST REHEARSAL BEFORE and the FIRST REHEARSAL AFTER a holiday, concert, or vacation
- The first and last rehearsals of the semester

As this is a teaching ensemble, events involving community relations and concerts are considered mandatory. Failure to participate in these events will affect the student's final grade. Students will be given a one-week notice prior to the event

^{**} It is understood that everyone is at a different vocal level. All students should make every attempt to produce the best tone possible at testing time. For example, fundamental technical approach to singing should not involve breathiness or pushed chest placement.

ATTENDANCE POLICY

- 1. Students are considered tardy at **1:00 pm on MTWR.** At that start time the student should be prepared to sing rather than in the process of gathering materials. And/or entering the rehearsal room. Those not prepared to begin are considered late. **Two points** will be deducted.
- 2. An absence from a performance will constitute a grade of \mathbf{F} for the semester.
- 3. See the above chart for punctuality for dress rehearsals and concert call times
- **4.** Anyone missing the dress rehearsal will not be allowed to perform in that concert which will constitute a failing grade. Therefore, please carefully consider the schedule before the drop/add period ends.
- 5. There is no differentiation made between excused and unexcused absences; use of absences is left up to the students' discretion. Documentation is REQUIRED for any absences to remove penalties. ALL DOCUMENTATION MUST BE SUBMITTED TO INSTRUCTOR WITHIN 2 weeks of return to classes to be considered.
- 6. Any student who misses more than 12 rehearsals (even with documentation) should consider a medical or regular withdrawal. Non-participation in 30% of the semester's regular rehearsals will not be accepted for a passing grade.
- 7. Every Student is responsible for learning and memorizing every piece of music in the "folder". Do not expect to be spoon-fed in rehearsal. Thus, tests may include pieces that have not been covered in rehearsal as much as other scores.
- 8. IF a student is unable to sing or participate for an extended time (more than 4 rehearsals in a semester) then the student needs to seek a medical documentation. Otherwise, a non-passing grade may be issued. It is not acceptable for a student to place himself/herself on vocal rest. A note from the respective applied voice instructor must be submitted to the director. Again, after the fourth rehearsal on vocal rest the student is required to submit medical documentation. Documentation must be submitted within two weeks after the fourth rehearsal "on vocal rest." It is understood that at times medical appointment are not readily available. In this case, the student must demonstrate an official document that an appointment has been scheduled.
- **9.** All students are required to attend ALL FAU choral concerts in which they do not perform. If a student performs in all concerts, this requirement will be waived. Failure to attend will result in a 10-point deduction from the final grade.
- 10. Students are responsible for arranging to make-up work missed because of legitimate class absence, such as serious illness, family emergencies, military obligation, court-imposed legal obligations or participation in University-approved activities.
- 11. Examples of University-approved reasons for absences include participating on an athletic or scholastic team, musical and theatrical performances, debate activities, and religious accommodations.
- 12. It is the student's responsibility to give the instructor notice prior to any anticipated absence and within a reasonable amount of time after an unanticipated absence, ordinarily by the next scheduled class meeting. (or the day of in the case of an exam)
- 13. Instructors must allow each student who is absent for a University-approved reason the opportunity to make up work missed without any reduction in the student's final course grade as a direct result of such absence. Students must purchase the required uniform. Price will be determined at the given semester according to current catalog prices. Uniforms must be paid for in full before it is ordered. Alterations needed are the responsibility of the student. The area of choral music has a seamstress who has agreed to follow the department's guidelines. If a student chooses to go elsewhere and the guidelines are not followed, then the individual student is responsible for remedying the situation and may have to purchase a new uniform. If, in through course of time, a uniform does not fit or look as it should, the student will be responsible for replacing it before the next performance. At every concert a designated graduate assistant will evaluate the individual's attire. Students will not be allowed to perform until the uniform meets departmental standards.

UNIFORM/REQUIRED MATERIALS:

- The "Black Folder" in good condition is required for performance
- WOMEN:
 - *Uniform purchased through department (hemmed to appropriate length)
 - *Sheer Black Pantyhose (full-length, no knee-highs)
 - * Black Ballet slippers (or leather jazz shoes). No heels, No laces
 - *Appropriate undergarments
 - *No watches, bracelets, nose or facial piercings at concert.
 - *Anything that is worn in the hair MUST be the color of the hair (not shiny, studded or cloth).

• MEN:

- * Black, single peak tuxedo jacket and pants (hemmed to the appropriate length)
- * Black vest and tie.
- * White Tuxedo Shirt
- * Black dress socks (not ankle length)
- * Black **PATENT** dress shoes
- * No watches, bracelets, nose or facial piercings at concert.
- *Anything that is worn in the hair MUST be the color of the hair (not shiny, studded or cloth).
 - FOR CONCERTS: Hair should be worn up and off the face. This will be discussed prior to the first concert.
- These items are the student's sole responsibility. Failure to comply with the exact uniform will constitute a failed performance (the student will not be allowed to perform.)
- Students with colored hair in blue, green, or anything that calls attention away from uniformity on stage will be asked to wear a wig
- UNIFORMS ARE EXPECTED TO BE NEAT AND WELL-CARED FOR. STUDENTS WEARING WRINKLED UNIFORMS WILL BE CONSIDERED NOT IN PROPER ATTIRE.

MAKE UP/ LATE WORK: As this is a performance based course it is not possible to make-up missing a performance or a dress rehearsal. If a music test is missed, it must be made up with 24 hours unless for vocal health issues, all of which must be documented.

Incomplete Policy: A grade of Incomplete will be assigned only in the case of extreme emergency or illness. This grade will only be assigned when such a situation precludes the students' ability to complete the Final Performance. If such a situation should occur, the student should contact the instructor prior to the start of the performance and should be in EXTREME cases only. Should this occur, the student will be required to complete the course the next time it is offered as no make up for a collaborative performance is possible or reasonable.



CLASSROOM ETIQUETTE:

- Students are expected to refrain from the use of handheld Internet or texting devices during class. Should a student be found in violation of this etiquette, they will be asked to leave class and take the absence.
- Cell phones should be turned off. Cell phones on vibrate still make noise and disrupt the rehearsal process. If you cell phone rings or vibrates during class or if you are seen on the phone (texting...), you will lose points from the FINAL GRADE and lose your phone for the rehearsal.
- Additionally, students are asked to sit in the chairs in a proper manner and keep feet from residing on other furniture.
- Out of courtesy to other students and to the professor, students are asked to arrive in a timely manner.
- Rehearsal begins promptly. Placing your belongings at your chair does not mean you are on time.
- Personal belongings should be placed at the side of the room. Students should have only their music, pencil, and water at their seat.
- All questions should be directed to the conductor (or student running a sectional). Focus is expected during rehearsal times and all markings should be made immediately.
- Rehearsal begins promptly. Placing your belongings at your chair does not mean you are on time. On time means being in your chair, all belongs at the side of the room, and music and pencil on hand ready to begin rehearsal. Only bottled water is allowed in the rehearsal room.

WHAT SINGERS SHOULD DO

The Area of Choral and Vocal Studies wishes to thank The Singer's Resource, the Texas Voice Center, Houston, and the University of Michigan Vocal Health Center for the following information:

- 1. **Maintain good general health**. Get adequate rest to minimize fatigue. If you do become ill, avoid "talking over your laryngitis" see your physician and rest your voice.
- 2. Exercise regularly.
- 3. **Eat a balanced diet**. Including vegetables, fruit and whole grains, and avoid caffeinated drinks (coffee, tea, and soft drinks) and alcohol. Avoid spicy, acidic, and dairy foods if you are sensitive to them.
- 4. **Maintain body hydration**; drink two quarts of water daily. SEP!
- 5. **Avoid dry, artificial interior climates**. Las Vegas has an average daily humidity of 36%, a relatively low amount of moisture. Using a humidifier at night might compensate for the dryness.
- 6. **Limit the use of your voice**. High-ceilinged restaurants, noisy parties, cars and planes are especially damaging to the voice. If necessary, use amplification for vocal projection.
- 7. Avoid throat clearing and voiced coughing.
- 8. Stop yelling, and avoid hard vocal attacks on initial vowel words. SEP!
- 9. **Adjust the speaking pitch level of your voice**. Use the pitch level in the same range where you say, "Umm-hmm?" [SEP]
- 10. Speak in phrases rather than in paragraphs. Always speak on "fresh breath"
- 11. **Reduce demands on your voice** don't do all the talking!
- 12. Learn to breathe silently to activate your breath support muscles and reduce neck tension.
- 13. Take full advantage of the two free elements of vocal fold healing: water and air.
- 14. Vocal athletes must treat their musculoskeletal system, as do other types of athletes; therefore,

vocal warm-ups should always be used prior to singing. Vocal cool-downs are also essential to keep the singing voice healthy.

- 1. **Stay informed**. Awareness is the key. Like many health-related issues, prevention is much easier and less expensive than cures. Take time to read available information concerning injuries associated with your art. [SEP]
