Course Objectives/Student Learning Outcomes

The goal of this course is to develop an understanding of the principles of magnetic circuits, which, in turn, lead to an understanding of the operation of electrical machines (AC and DC), and transformers. A further goal is for the student to learn applications of transformers as well as AC and DC electric power generation. Upon completion of this course, the students should be able to:

- Understand how Ampere's law applies to analysis of magnetic circuits
- Understand how Faraday's law applies to analysis of magnetic circuits
- Understand the loss mechanisms in magnetic circuits
- Design a transformer to meet a specific set of operating specifications
- Understand fundamental concepts involving three-phase circuits, power, and power measurement in ac circuits
- Understand the basic principles of the 3-phase induction motor (including its general construction) and the fundamental equations describing its behavior
- Understand the construction, characteristics, and uses of modern synchronous generators
- Understand dc generator and dc motor operation, relevant equations, applications, and the way the windings are made.

Time Commitment Per Credit Hour
