The ESE Department is proposing the courses and curriculum for the three certificate programs for our new post-secondary program for adults with developmental disabilities (Academy for Community Inclusion). You first saw the summary of the programs and the first three courses in October. These courses passed the various faculty review committees and the Senate and will be on the books at the Jupiter campus starting this Spring.
