Curriculum Change to College Business Core

To specify the Economics courses required for the MIS majors in the College of Business Core, the Department of Information Technology and Operations Management (ITOM) proposes the following change to the FAU University Catalog. The changes highlighted in yellow are the proposed changes.

Rationale: The current curriculum description of Economics requirement for the MIS major reads "any 3000-4000 level Economics course," which provides no specific guidance to courses deemed most appropriate. With the proposed change, we follow the practice of other COB majors to specify the Economics courses instead of leaving it broad and unclear. This change directs students to take the courses that will satisfy International Perspectives while meeting the Economics requirement. This would help expedite their progress toward graduation.

The proposed change was approved by the chair of Economics department.

The faculty voted in favor of such changes in the program description on September 25, 2015.
