III. NEW BUSINESS

1. College of Arts and Letters *Theatre and Dance*

Guest Kathryn Johnston of the Theatre and Dance Department presented five new courses and program changes in the B.A. and B.F.A. degree programs. The five new courses will serve as electives for the time being until a new B.F.A. concentration is added, at which time they will also serve as requirements for the new concentration (more on this below). **The five new courses were approved by the UUPC.**

In explaining the catalog changes, Professor Johnston shared that the department wishes to remove the foreign language graduation requirement from its B.F.A. program in order to add more credits in major-specific courses. This will make the program more competitive with those at other state universities that require a high number of credits, while FAU's program requires only 120. A letter of support was received by the Department of Languages, Linguistics and Comparative Literature for this change. Next, she emphasized that the B.F.A. with its two concentrations never had a list of specific core courses. One of the catalog changes will rectify that. Finally, she added that the new B.F.A. concentration, to which the core courses will also apply, will be in Design and Technology. This one will be presented to UUPC in the near future. **The degree program changes were approved by the UUPC.**

Guest Donna Chamely-Wiik reiterated that these two courses have been reviewed and approved by the Office of Undergraduate Research and Inquiry. **The UUPC approved the RI courses**.

2. College of Science

Guest Dr. Hongwei Long, Mathematics, presented a new certificate in Data Science. There followed a long discussion about the topic of Data Science and the fact that other colleges may be working on similar offerings. Registrar Hodge suggested that Mathematics request a response from Computer Science to say they have no objection to the certificate. Dr. Long replied that Computer Science did not respond when they were contacted about this item, but added that the College of Business did respond favorably. EG Representative Dan Meeroff reached out to Computer Science during the meeting and received a message indicating that Computer Science would not object to Math's certificate if Math would not object to the Data Science certificate being prepared by Computer Science. The Committee members determined that both parties need to have more discussion on the various certificates, perhaps seeking a way to collaborate. BA Representative Ethlyn Williams put forth a motion to table this item until February's UUPC meeting, allowing more time for discussion. The Committee agreed. **The Data Science Certificate was tabled.**

The second item for the College of Science was a prerequisite change. **The UUPC approved this change.**
